





to solve their problems in informal ways rather than involve attorneys/lawyers, and continue to do so. This indicates a lack of confidence in the judicial system. We also lay our hopes for the development of the legal services market on reforms of the antitrust authorities and the legislation in general.

We remain optimistic and believe that reforms will take place, as there is no other choice. We have seen our country in ruins, there is only one way left. After all, we have changed, and have now begun to lay the foundation of a new country. I am sure that the country will be better, as we are steadfast in our purpose and keep forging ahead with it.
